#### **DEADLINE FOR REGISTRATION IS 30 APRIL 2024**

The Contact persons of each Association/Company or Single Student must access the online platform https://opesdanzaeventi.it/login Register and register. Enter all the Required Data of the Participants;

In order to complete the registration you must send to the email montesilvanoonstage@opesdanza.it the following documents:

- a copy of the transfer accounting officer;
- Copy of the last page of these Regulations stamped and signed for acceptance by the legal representative of the School, Association/Society of Dance or by the Parent;

#### **JURY**

The jury is composed of recognized personalities of the International Dance.

They will express their opinion with a single vote for each choreography.

METHOD OF JUDGMENT: Total vote for each juror from 5.1 to 10.0 for each choreography. the members of the jury will be:

Judging parameters implemented by

- Technical Judgement (level and technical quality)
- Artistic Judgment (expressiveness, interpretive ability, musicality)
- Musical Judgment (stage presence and physical presence)
- Judgment Ideation Choreography (originality of the idea staged)

#### **AWARDS**

Each Dancer, will receive a Certificate of Participation valid as a credit point for school education.

The Winners will be awarded with national and international scholarships, Cups, Plaques, Medals, clothing and gadgets for dance.

#### **GENERAL PROVISIONS**

On stage, at the time of the exhibition, small-sized objects and mobile sets are allowed, as long as they are easy and quick to transport, candidates assume the responsibility of quickly removing the set at the end of the exhibition.

Competitors will not be allowed to use makeup or body creams that can dye or make the dance floor slippery, or use liquid substances, paints, powdered talc or anything else, which endanger or hinder the proper continuation of performances.

Recordings not considered professional to the listening may be refused by the Jury examiner and therefore be cause of elimination from the competition; there will be no rehearsals on stage before the performances in competition.

## **PHOTOS ANE VIDEO**

These Regulations authorize the Organizers to use the images and the shots taken during the event, for information, advertising and communication purposes, in the press, web and television. Also photos will be taken by professional operators who will take care of the sale.

## **CAUSES OF FORCE MAJEURE AND FINAL RULES**

By signing these rules, the Legal Representative of the Association/Dance Society and/or the Parent fully and unconditionally accepts the following points:

- 1. If for organizational reasons the date of the event changes or the event is cancelled, the change will be communicated with at least 7 days notice on the established date.
- 2. If there is no minimum number of participants in one of the Event Categories, the organizers reserve the right to merge or delete one or more categories of this edition.
- 3. In the event that the Competition cannot be held for reasons of force majeure or the lack of a minimum number of members, the refund of the fees paid will be obtained through a voucher to be used for the activities of the current year of OPES DANCE.
- 4. In case of cancellation or non-participation by the members, there is no refund of any fee paid. In addition, by signing these Regulations, the Legal Representative of the Association/Società di Danza and/or the parent, declare that each dancer is in possession of a medical certificate of fitness for sports and an accident insurance cover, that guarantees the coverage of the insured also outside the Association/Società di Danza for Shows and Events. The representatives of the Associations/Società di Danza and/or the parent, assume all responsibility for the damage that their members may cause to things, people or themselves.
  - Any decision is the responsibility of the Organisers for anything not covered by these Rules.
  - The Organizers reserve the right to make changes to the same, at any time, promptly informing the participants.
